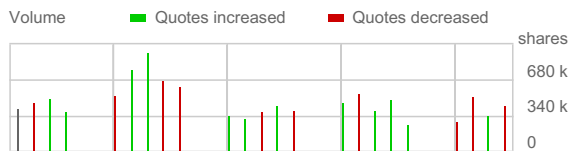
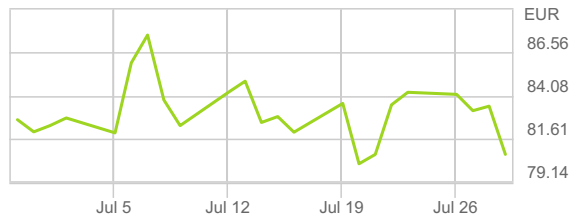


COMPANY PROFILE
